10. To discuss, take any necessary action, and adopt the District's 2027 budget. In accordance with Section 551.043 of the Texas Government Code, the ESD 20 Commissioners will discuss the District's 2027 budget. The taxpayer impact associated with the 2027 budget is unknown at this time and cannot be known until after the District's 2027 budget is adopted.

Pursuant to Section 551.043 of the Texas Government Code, no action will be taken to adopt any amendments to the District's 2026 budget at this meeting. The District's current fiscal budget has been posted on and is clearly accessible on the District's website. Taxpayer Impact Statement: There will be no taxpayer impact associated with the 2026 budget at this time.
